INTERACTION Expectations for timely and regular feedback from the instructor are clearly stated (questions, email, assignments). Expectations for interaction are clearly stated (netiquette, grade weighting, models/examples, and timing and frequency of contributions). Overall, I feel that my course is well-designed. As it is my first experience in online learning, there are definitely some items that need to be improved. I plan to adjust sevearl of my links to be more descriptive. I also plan to ensure that my videos have pdf transcripts that are accessible by students. There are some areas of this form that I don't think apply to my Fourth Grade audience, but I did include more grade-appropriate elements. For example, I do not have a syllabus, but I did have a detailed course calendar for students to follow. Also, I do not have links to plagiarism sites, but I do have several activities that request students to use the EasyBib extension within a Google Doc to help them format sources where they find information. I definitely feel this is a great tool to assess your overall course design, and it did help me to find several easy changes to make that will greatly improve my overall course structure and presentation.
